

# A strong foundation for a bright future

2016 promises to be an exciting year in Colwood, with significant development at Royal Bay and in the centre of the City. A modest increase of 3.5% in municipal property taxes will allow for enhancements to streets, sidewalks, trails and parks as well as sewer extensions and investment in safety and emergency services.

## *Fiscal strength*

Prudent financial planning is a cornerstone of everything the City does. Over the past year we have reduced the City's general debt by more than 37% and built up reserve funding significantly. This strong financial position gives us the ability to continually invest in our community and the flexibility to act on unforeseen issues as they arise.

## *Community investment*

We work to continually improve the safety and enjoyment of our city by investing in public safety, maintaining and upgrading infrastructure, creating transportation connections, enhancing public spaces and encouraging events that strengthen our community.
