| <b>If you are not on the list of electors</b> , you may register at the time of voting by completing the application form available at the voting place and making a declaration that you meet the requirements to be registered as set out below:<br><br>All electors must meet the following qualifications: <ul style="list-style-type: none"><li>• be 18 years of age or older on general voting day on October 17, 2026</li><li>• be a Canadian citizen</li><li>• be a resident of British Columbia for at least 6 months immediately before the day of registration</li><li>• not be disqualified under the <i>Local Government Act</i> or any other enactment from voting in an election or assent voting and not otherwise disqualified by law</li></ul><br>Resident electors must: <ul style="list-style-type: none"><li>• be a resident of the City of Colwood on the day they register to vote</li></ul><br>Non-resident property electors must: <ul style="list-style-type: none"><li>• not be entitled to register as a Colwood resident elector</li><li>• be the registered owner of property in Colwood for at least 30 days immediately before registering to vote</li><li>• provide written consent of the majority of the owners for only one registered owner of the property to vote</li><li>• not vote on behalf of a corporation, or as a non-resident property elector, based on a property owned wholly or in part by a corporation</li></ul><br><b>To register, resident electors</b> must produce <b>2 pieces of identification</b> (at least one with a signature). The identification must prove both residency and identity.<br><br><b>To register, non-resident property electors</b> must produce <b>2 pieces of identification</b> (at least one with a signature) to prove identity, <b>proof</b> that they are entitled to register in relation to the property, and, if there is more than one owner of the property, <b>written consent</b> from the other property owners. |                                                                                                                                                                             |
