RECOMMENDATION

THAT the 2020 Annual Development Cost Charges Report be received for information purposes only.

SUMMARY AND PURPOSE

Municipalities are required to report annually on the development cost charges collected and used during the fiscal period. The 2020 development cost charge (DCC) activity is reported in the attached Appendix 1.

BACKGROUND

Section 569 (1) of the *Local Government Act* requires a municipality to report on development cost charges received and expended during the fiscal year. This legislated report must be prepared annually and be made available to the public.

The City's road development cost charge bylaws may be cited as "Colwood Development Cost Charge Bylaw (Major Roads), 1998" and "Colwood Development Cost Charge Bylaw (Major Roads), 1998, Bylaw No. 441, Amendment No. 1, Bylaw No. 1528, 2014". The City's sewer development cost charge bylaw may be cited as "Colwood Sewer Enhancement Development Cost Charge Bylaw No. 1431, 2011".

City staff are currently updating the Colwood Development Cost Charge Bylaw (Major Roads), 1998. On March 22, 2021 Council considered Development Cost Charge Bylaw – Roads, Bylaw No. 1836, 2021 and gave first and second reading. This bylaw is tentatively scheduled for third reading at the May 25, 2021 meeting of Council and will then be directed to the Ministry of Municipal Affairs for review and endorsement. Adoption of Development Cost Charge Bylaw – Roads, Bylaw No. 1836, 2021 is anticipated within 2021, third quarter.

OPTIONS / ALTERNATIVES

Option 1: Receive the report for information.

This will provide adherence to the legislation.

Option 2: Do not receive the report for information.

This will be in contravention of the legislation.

Option 3: Request staff revise the report and bring back to Council to receive for information.

This could provide adherence to the legislation if done so prior to June 30, 2021.

CONCLUSIONS

In order to adhere to the *Local Government Act*, the 2020 Annual Development Cost Charges Report must be received for information by June 30, 2021.

COMMUNICATIONS

The public will have access to this report through the meeting agenda and Council resolution to receive for information.

FINANCIAL CONSIDERATION

Development cost charges are recorded as deferred revenue when collected. When spending is authorized in accordance with the terms of the City's development cost charges bylaws, the corresponding amount is recorded as revenue and as a capital expenditure.

STRATEGIC PLAN AND RELATED POLICIES

This report supports Council's strategic objectives of responsible financial management and open and transparent governance.
