

Colwood has the 4th lowest property tax rate in the Capital Region.

We're keeping your taxes in check as our community grows

Even with rising costs and many exciting developments and improvements underway, we've worked hard to rein in municipal property tax rates. Most residents will see a modest increase of about 3.43% over last year, which, for the average household, works out to about \$52.

Planning thoughtfully, spending wisely

Using federal gas tax funds and other grants effectively means that the cost of many major planning initiatives, road improvements and park enhancements won't add to your tax burden.

We planned ahead to make major capital purchases before the HST changeover so that Colwood avoided the financial burden that some municipalities now face.

Developments in the heart of Colwood and the Royal Bay area will bring new residents and businesses to our community. We've been busy getting ready to welcome this growth.

An economic development strategy will guide how we work with businesses to strengthen our financial base.

What city services do your tax dollars pay for?

Each dollar you pay in municipal property tax goes toward funding a variety of services and amenities that help make Colwood a great place to live, work and play. Here's how each dollar breaks down:



Grants

Colwood is proactive in applying for grants and other funding that helps to offset the cost of maintaining and improving our City.

Understanding sewer fees.

- Properties connected to municipal sewers pay a sewer user fee to help keep pipes, infrastructure and equipment in safe working order.
- All Colwood property owners pay a portion of the cost of the planned Capital Regional District (CRD) Regional Sewage Treatment Facility.
- Properties with septic systems pay the CRD Onsite Sewage Parcel Tax which allows the CRD to monitor for safety of septic systems.
