

# Enhancing services while planning for the future

Colwood has adopted an award-winning, proactive approach to ensure funding is in place to keep tax rates level over time. The *average* residential property will see an increase of about \$56 on the municipal portion of their 2019 tax notice.

Colwood's financial health continues to improve, and the 2019 financial plan sets a course for the delivery of high quality and sustainable services based on four strategic priorities:

- Resource Management: controlling costs through effective management.
- Economic Growth: expanding the tax base with new commercial and employment opportunities.
- Placemaking: creating places where people want to spend time and improving the routes to get there.
- Service Excellence: a committment to customer-focused service and continous improvement.

# 2019-2023 Financial Plan highlights

#### Planning for infrastructure costs

The City's Sustainable Infrastructure Replacement Plan invests an additional \$3.6M in capital reserves, which will allow the City to develop detailed capital plans for roads, parks, sewers, and storm systems.

# New standards for parks, boulevards, roads & utilities

New standards for the maintenance of parks, boulevards, roads and utilities will be established based on the City's award-winning budgeting framework which demonstrates the real cost of providing services.

#### **Enhancing public safety**

As Colwood grows, so too does the need for investment in protective services. The 2019 financial plan invests an additional \$2.7M for additional RCMP officers and staff.

#### **Transportation planning**

An updated Colwood Transportation Master Plan will integrate community needs, transportation studies, development plans, BC Transit enhancements and potential ferry options to maximize improvements to streets, sidewalks, trails, cycling routes, transit options, and overall traffic flow in Colwood.
